<u>Summer Youth Employment Program</u>

Community Action's Employment & Training Division will soon be recruiting for the 2022 Summer Youth Employment Program. This federally funded summer program is designed to allow participants the opportunity to explore interests and career pathways, develop workplace skills and engage in learning experiences. This program is available to youth ages 14 to 20 who meet federal income guidelines. Youth participants are matched with employers throughout Wyoming County based on their interest, location, age, and skill ability. Work experiences are generally scheduled for 5 weeks or 125 hours during the months of July and August but are occasionally extended into September. Youth are paid minimum wage (currently \$13.20 per hour).

Employers participating in the Summer Youth Program agree to provide daily work assignments and supervision. Community Action pays for 100% of the youth wages and fringe and provides career and counseling support.

30-35 youth are typically enrolled each summer with an average of 10-15 employers participating, from both the public and private sector across

Wyoming County.








April is Volunteer Month!
